To all AWBs

You are aware that the institutional reforms process is underway with full vigor and its strength. SIDA along with its institutions. Area Water Boards and Farmer Organizations are striving hard for the improvement of water management system in the province of Sindh. The entire staff is participatory and the success envisioned in the maximum work by each of us representing various institutions, I would like to appreciate the efforts of Area Water Boards made for the promotion and success of institutional reforms in irrigation and drainage sector. However, the road is less traveled and we have to work collectively keeping our pace faster to make positive and sustainable impact.

MDS OF AN LETTER TO AREA WATER BOARDS

The roles and responsibilities entrusted to the Area Water Boards as per Sindh Water Management Ordinance-2002 are given below:

- Operate and maintain the parts of irrigation system conferred on it.
- Operate and maintain the parts of drainage system conferred on it.
- Carry out flood protection and maintain infrastructure within its command area;
- To receive irrigation water from the SIDA and deliver the same in agreed quantities to the various FOs or, as the case may be, to other agricultural users, and distributaries of drinking water, Local councils, industries or wetlands in the manner and on the terms and conditions as may be negotiated between the AWBs and the parties concerned and to receive drainage effluents at the designated points and convey the same to designated outfall drains; · Operate and maintain the irrigation, drainage and flood infrastructure located within its territorial jurisdiction.

The tasks and responsibilities of AWBs as per IDMT are as under:

- AWBs shall provide the assured supply of not less that design discharge of water at the Head R e g u I a t o r o f t h e Distributary/Minor/Lift Channel. In case of excess discharge available in the parent canal, it shall be made available to FOs proportionately.
- The Supply of water to Distributary/Minor/Lift Channels shall be closed for annual canal closure period or as the AWB decides for maintenance of the canal system. The AWBs shall inform the FO of the precise dates of the closure at least two weeks

before water supplies are cut off.

- If due to unavoidable circumstances there is shortage of water at the barrage, canal breaches, their alteration, the AWB shall not be liable to provide the assured supplies. It will however, attempt to provide as much water supplies to the FO as possible. If water supplies to the FO are reduced under avoidable circumstances, the AWB shall however award compensation to the FO as mutually determined:
- When under unavoidable circumstances discharge in the



canal is less, the AWB shall supply water in rotation to serve the legitimate demands of the water users on different distributaries and minors. For the purpose the AWB shall obtain the consent of the FO whilst making rotation schedule as an assure that the rotation schedule is formulated in such a way the rotation is allocated proportionately to the different distributaries/minors.

The Area Water Board shall install measuring gauge at the up stream and downstream of regulators along gates opening and calibrate the same before transfer occurs. The parties shall certify that the remission in Abiana. Drainage

cess, non-agricultural use charge and lease/rent. The damage caused the system due to that reason will jointly be repaired.

- The AWB shall suspend/stop the supplies of water and other services to the FO in the case of non-payment of Abiana, drainage cess, non-agricultural use charges and lease rent after prior notice but not before the commencement of the next season.
- The AWB shall form time to time provide technical guidance at the request of the FO. In the case of higher discharges in the canal due to heavy rains, the AWBs with the consent of the FO shall allow more discharge to the Distributary/Minor up to safe limits to save the canal.

It is therefore, the duty of Area Water Boards from the top to the bottom to implement the provisions made in the law and IDMT signed with the FOs in letter and spirit so that real benefits of the reforms are provided to the public. Moreover, I would praise every step, taken under Law. to promote the objective of reforms and protect the interests of the institutions. I also hope that you will work hard to achieve the goals with keen interest, persistence determination and especially leave no stone unturned to get system fully functional and self sufficient by improving the recovery of Abiana and providing irrigation water at the tail section of each Distributary.

FO CONVENTION IN MIRPURKHAS

A Convention of farmers' organizations was convened by SIDA in collaboration with Nara Canal Area Water Board on 10th August 2007 at Mirpurkhas. The convention was presided over by Mr. Mohammad Hashim Leghari, the Managing Director SIDA. Syed Muzafar Hussain Shah, the then Speaker of Sindh Assembly was the chief guest.

The Speaker stressed, the chairmen of farmers' organizations should be authorized to maintain water gauge and discharge and lodge FIR against water thieves without involving irrigation officials. There were, however, complaints that the watercourses of the some chairmen of farmer organizations had been found tempered with, he added

He said that a bill for amendment to the old Tenancy Act would be presented by a committee in the next Sindh Assembly session, which would define the responsibilities of peasants and landlords.

Mr. Shah said that in the light of the principle that the tail-end

Mohammad Hashim Laghari, said that farmers' organizations were playing a positive and desired role in the distribution of water in a judicious and equitable manner, which might help eliminate poverty in future.

He said that a growers' convention would be organized in each division of the province to

listen and to solve their problems. The work on de-silting of LBOD main drain, sub drains and spinal drain had been carried out at a cost of Rs. 113 million, he added.

He said SIDA was operating the system successfully with the cooperation of farmers and farmer organizations were working effectively in the province.

Prof. Aijaz Qureshi, the General Manager Transition, said, though he was feeling there was some restlessness among farmers, yet this was the sign that they were going ahead democratically and farmers had right to raise their voice without any pressure. He hoped that soon they shall resolve all the ups and down in dealing with farmers and FOs.

Mr. Nazeer Ahmed Memon, the Social Development Specialist SIDA, said, "We believe in user's management, we want to ensure the more participation of farmers in this new system which is running successfully among many

developed and developing countries. He said it never happened anywhere in the world that people/farmers have been given contracts to improve and rehabilitate the irrigation system. We have made it possible.

The Nazim of union council Jhillori, Yar Mohammad Baloch demanded that the authorities should immediately remove illegal pumping machines installed on the bank of Nara Canal. The MD responded that he had visited the area and found that most of the pumps were sanctioned. He further made clear that SIDA had already issued directed to remove the illegal pipes.

Earlier, chairman of Nara Canal area water board, Khair Mohammad Bhurgri, FOC Chairman Javed Junejo, Ghulam Mustafa Ujjan and others addressed the convention.

The main purpose of establishment of these kiosk is to provide an opportunity to the farmers to have an easy access to the necessary information related to irrigation water, Agriculture and the market.

Under Sindh On-Farm Water Management (SOFWM) Project, co-financed by World Bank 100 distributaries / minors managed by Farmers Organizations (FOs) will be rehabilitated / improved in all three Area Water Boards i.e. Nara Canal Area Water Board (NCAWB), Left Bank Canal Area Water Board (LBCAWB) and Ghotki Feeder Canal Area Water Board (GFCAWB).

SINDH WATER SECTOR IMPROVEMENT PROJECT (WSIP)

PHASE-

Water Sector Improvement Project Phase I (WSIP I) would cover jurisdiction of 3 AWBs. Total Cost of the Project is US\$ 175 Million with World Bank share US\$ 150.2 Million and GoS share US\$ 24.8 Million. Project period is 5 years July 1, 2007 to April 30, 2013.

The project objective is to improve the efficiency and effectiveness of irrigation water distribution in three AWBs (Ghotki, Nara and Left Bank), particularly with respect to measures of reliability, equity and user satisfaction. This would be achieved by

Deepening and broadening the institution reforms that are already underway in Sindh.

Improving the irrigation system in a systematic way covering key hydraulic infrastructure, main and branch canals, and distributaries and minors.

Enhancing long-term sustainability of irrigation system through participatory irrigation management and developing institutions for improving operation

Third meeting of Stakeholder Fora was held on March 4, 2008 in the Office of the Managing Director SIDA.The meeting was chaired by Mr. Mohammad Hashim Leghari, the Managing Director SIDA/ Chairman, Fora.

In the start with permission of chair an open discussion was held on SIDA reforms and the performance of Organization.

Following points emerged from the discussion:

- To make efforts to address the needs of communities along with preparing them for irrigation reforms.
- To make efforts to regulate water for ensuring equitable water distribution and delivering fair water share down to tails.
- To make efforts to stop the groundless propaganda against SIDA.
- To monitor water availability in minors & distributaries weekly instead of fortnightly and to send reports prepared by M&E Consultants to related AWBs.

To talk to Government for transition of powers from Irrigation

and maintenance of the system and cost recovery.

The improved water management would lead to increased agricultural production, employment and incomes over area about 1.837 million ha or more than 30 percent of the irrigated area in Sindh, and one of the poorest region of the country

Expected project outcomes would include

Improved efficiency for water delivery and reduced water logging.

Greater equity in the distribution of water and management of water delivery through stakeholder participation

Improved financial

sustainability resulting from rehabilitation of infrastructure and increased cost recovery from users, and (iv) increased agricultural production and incomes for estimated 4.0 million beneficiaries within the project area.

Direct quantifiable project benefits would include annual incremental agricultural production with estimated value of Rs. 3.4 billion (June 2006 prices) and creation of additional 4.39 million workdays per year of farm labor at full development due to increased cropping intensity and yields.

Indirect and non-quantifiable benefits would include reduced drainage requirements; reduced soil salinity risks; reduced incidence of stagnant pools of water and decrease in mosquitoborne disease; and reduced negative impact of water logging on buildings and roads.

After giving satisfactory remarks, the stakeholders insisted that speed of works must be increased to complete the target at the end of running year. It was also decided to make efforts for taking up the remaining 19 branch canals in Water Sector Improvement project.

The forum was informed that under SOFWM-P 33 newly formed FOs have been trained.43 specialized trainings have been delivered. 57 FOs have been registered whereas; 18 FOs have singed IDMT and re-elections had been conducted in 183 FOs. According to PAD, page 44(2.04) for the purpose of Information dissemination and demand promotion, three information kiosks/ centers are activated one in each AWB respectively.

After the discussion the stakeholders advised that process of signing IDMT agreement, reelections and target of different trainings on all the distributaries and minors should be accomplished possibly soon as the project was near to its end.

Social Development Cell (SDC) is striving hard for active participation of farmers (Male and Female) in irrigation Reforms. The SDC forms farmers' organizations and enables them through different kinds of trainings to run Irrigation System at distributary/Minor level and concentrates on bringing organizational uniform and discipline among farmers at the platform of FO.The cell also ensures the women participation in the program so that the role of women may develop in Water Management. The cell works under the supervision of Social Development Specialist (SDS) and has its field teams under various local (NDP) and Foreign funded (SOFWM) Projects. The team one is known as Social Mobilization Groups (SMG) consists of GL Training coordinators, Team leader, Social Mobilization Officers (SMOS) and Field Assistants. The teams are located at various areas falling in the all Kirpe AWBs, i.e. Nara. Cinalf (MpK, Sangher, K.G.M, U.k.), left bank (TMK, Badin) and Ghotki (Ghotki, Mirpur Mathelo/Dahrki)

Objectives and Activities of Social Development

- Promote farmers' participation in institutional reforms in irrigation & drainage system.
- Coordinate with legal, other experts and officials in technical and operational aspects
- Facilitate gender participation in the institutional reforms in irrigation and drainage.
- Disseminate accurate information regarding the

project's objectives, polices, and programs to stakeholders.

- Publish newsletter and develop written material for promotion of institutional reforms.
- Provide assistance to existing Farmers Organizations. Arrange press briefing, conferences, and workshops.

organizations. In this regard, in 27 Basic Trainings events 354 Farmers Members of 62 newly formed FOs have been trained for run their routine business of their minor/Distributary. Under Specialized training component SDC has provided advance courses trainings to FOs and Staff. In this regard in 39 Training events, 1076 participants including staff and farmer

World Bank Mission Visits SIDA

During May 28 June 3, 2008, a World Bank Mission visited Sindh province to carry out an implementation review of Sindh On-form Water Management Project. The main objectives of the Mission were to review the progress of individual components, implementation arrangements, fiduciary aspects and the time schedule of the Project and identify key issues and actions needed to enhance project performance and ensure timely completion of the Project. The Mission was comprised of Tumurdavaa Bayarsaihan (Senior

Rural Development Specialist), Muhammad Ehsan (Water Resources Specialist/Conultant), Resources Specialist/Conultant), Abdul Qaiyum Sheikh (Agriculture Specialist/Consultant), Javaid Afzal (Environment Specialist), Uzma Sadaf (Procurement Specialist), Riaz Mahmood (Financial Management and Disbursement Specialist) at Ne Mission arrived at SIDA Secretariat on May 29, 2008 and welcomed by Mr. Muhammad Hashim Leghari, the Managing Director SIDA and other officials of SIDA.

The Mission was given briefing by M.D SIDA in which it was portrayed that under the Sindh On-Form Water Management Project the works of improvement and rehabilitation of minors and distributaries were going on quite satisfactory. He further briefed the Mission that such works were running on 100 minors and distributaries.

During this, the Mission also met farmers of different FOs who were given Community Based Contracts (CBC) and inquired them how the works of improvement and rehabilitation were going on and what were the major bottle necks in achieving the targets timely. The Mission was told that the during last some months the prices of material used for the improvement and rehabilitation were increased , renabilitation were increased , therefore it was very difficult to complete the target within the cast provided for the purpose. The Mission noted this problem and ensured that the matter would be addressed in proper way. The addressed in proper way.
